Sub: Distribution of Social Service fees among Colleges and NSS Bureaus.

Sir,

In inviting a reference to this Department letter No.16040/HE., dated 18.06.2013 on the subject cited above, I am directed to say that you have been requested to collect Rs.10/- only per student towards Social Service Fees head at the time of Admission into +2 +3 & P.G. Classes. Out of the said amount Rs.4/- only is to be retained at the College for development of NSS activities and Rs.6/- is to be deposited in the NSS account of the respective Bureaus of Universities/CHSE etc. The Colleges having no NSS unit will remit the entire collection amount to the concerned Bureaus.

Now it came to the notice that some Colleges are not paying Rs.6/- or Rs.10/- per student to their NSS Bureau as the case may be. It is also further noticed that the NSS Bureaus are not maintaining separate account towards collection of social service fees for which it becomes difficult to identify the amount of such fees collected from the different Colleges.

You are therefore requested to instruct the Principals of all Colleges to deposit the Social Service fees to their NSS Bureaus immediately. Besides, the Programme Coordinators of your NSS Bureau may be instructed to deposit the amount of social service fees in a separate account in any Nationalized Bank.

The action taken report may be submitted to this Department at an early date.
