Sir/Madam,

I am directed to say on above cited subject that, Govt. of Odisha, Department of Higher Education in their letters No.16040 & 16043 dt.18.06.13 have enhanced the existing rate of "Social Service Fees" from Rs.5/- to Rs.10/- per student at the time of admission from the academic session 2013-14. You are therefore requested to ensure collection of Social Service Fees at the revised rate of Rs.10/- per student taken/ taking admission into the Higher Secondary (+2) course in your institution from the academic session 2013-14 onwards.

The Govt. in the said letters have also decided that the institutions having NSS units (exclusively under CHSE,Odisha) shall retain Rs.4/- per student with their institution towards development of NSS activity and remaining Rs.6/- per student shall be deposited to the NSS fund of the Council. Similarly the institutions having no NSS unit of the CHSE, Odisha will deposit entire collection amount of Rs.10/- to the NSS fund of the Council.
